TERMS AND CONDITIONS

5. Repairs and replacement of spare parts will be carried out through the Company's authorized service provider if such repairs or replacements are determined as necessary or required by the Company in its sole discretion.

6. This Scheme shall not be clubbed with any other Schemes. In the event where two schemes declared by the Company and in force and effect at the same time relate to the Warranty Period, the Scheme having the longer Warranty Period shall be applicable and the other Scheme shall be considered to be inoperative.

7. Godrej or its authorized service provider (ASP) will collect any parts or components replaced to which this Scheme is applicable.

- d. Failure of condenser and evaporator coil due to deterioration due to site/ climatic condition will not be covered under extended warranty scheme.
- e. The extended warranty is limited to repairs and replacement of certain spare parts that are referred to in the table stated above; and thereby does not cover the product replacement in any circumstances.
- 9. In case of any conflict the decision made by the Company shall be final.

10. The Warranty Period on the replaced or repaired Product shall be reduced to the balance period, as computed from the date of first sale of the Product.

- 11. Product features, specifications and warranty terms are subject to change without notice.
- 12. Offer is not applicable to institutional sale customers.
- 13. Special discount on the service charges for the part not covered in warranty.

14. The extended warranty is limited to repairs and replacement of certain parts that are referred to in clauses stated above; and thereby does not cover the product replacement in any circumstances.

- 15. No service charges for the parts covered in warranty.
- 16. Warranty does not cover accessories to the appliances.

INSTRUCTIONS FOR THE CUSTOMERS

- 1. To avail the benefits, the customer must register themselves on site <u>www.godrej.com/appliances/extended-</u> <u>warranty</u> and upload the Product and invoice details within 7 days of purchase.
- 2. In case the customer fails to register, the warranty will not be considered for any extension and the original warranty for the two-year period will only be applicable.
- 3. The defective Product will be repaired by Godrej in a reasonable period of time at Godrej's discretion. Godrej's decision in terms of defect found shall be final and binding and Godrej shall hold the final right to decide the applicability of the warranty terms, including the decision to repair the Product will be at Godrej's discretion based on the report submitted by Godrej's service representative. .
- 4. This warranty will be valid only for sale through Godrej Exclusive Brand Outlets, Godrej Preferred Brand Outlets, authorized dealers and authorized retail counters. The warranty card must be signed & stamped by the dealer and must be produced along with the original bill at the time of any claim.
- 5. The product should include the original label which shall serve as a means of identification of the product to confirm the warranty.
- 6. Please inform them regarding the details of the defect, model details and serial no (if any) of the product.
- 7. Warranty is applicable from date of purchase i.e. invoice date, against defective material or workmanship. In case of any such defects, Godrej & Boyce Manufacturing Company Limited Appliances Division undertakes to get the appliances repaired under the Warranty Period, subject to terms and condition as set out under this document.
- 8. The transportation cost will be charged to you and any cost incurred towards complaint attendance is also to be borne by you.
- 9. All transportation and handling expenses incurred while repairing will be payable by customer.
